ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Jharkhand Educational and Rural Development Society, Koderma, Village - In the Campus of Law College, Street/Road - Jharkhand Vidhi Mahavidyalaya Koderma, Taluka/Mandal - Koderma. Town/City - Koderma. Dist. - Koderma. Jharkhand - 825409 has applied for grant of permission to Jharkhand Teachers Training College, Jhumari Telaiya, Village - Plot No. 3515, Khata No. 630, Street/Road - Telaiya Basti, Taluka/Mandal - Koderma, Town/City - Plot No. 3515, Khata No. 630, Dist. - Koderma, Jharkhand - 825409 (Application No. ERCAPP201646270) (ID No. 7194) for B.Ed. (Addl.Intake) Course online on 30.06.2016 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 11.07.2016.

2. AND WHEREAS, the Eastern Regional Committee in its 227th meeting held on 8th - 10th December, 2016 considered the matter and as decided that Show Cause Notice was issued on 22.12.2016 to the institution.

3. AND WHEREAS, the institution had submitted reply dated 16.12.2016 and received in this office on 02.01.2017. The ERC in its 236th meeting held on 25th - 28th March, 2017 considered the matter and as decided that Show Cause Notice was issued on 03.04.2017 to the institution.

4. AND WHEREAS, the institution had submitted reply dated 07.10.2017 and received in this office on 07.10.2017. The ERC in its 245th meeting held on 23rd - 24th October, 2017 "after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time and reply in response to SCN issued before VT, discussed the matter in detail and observed as under:

a Show Cause Notice was issued on 03.04.2017 on the following grounds:

(i) The institution was granted recognition for B.Ed. course on 08.07.2013 with an 100 intake (two units). Now, the institution applied for B.Ed. (Addl.Intake) for one unit more. As per NCTE Hqrs. Letter No. 49-1/2016/NCTE/N&S/47149 dated 08.12.2016, single institution shall not enhance intake more than 100 i.e. two basic units in the B.Ed. course.

b. In response, the institution submitted reply vide letter dated 07.10.2017 informing therein to further process the application for additional intake in B.Ed. which has already been permitted by University as well as Government of Jharkhand. However, the institution is still deficient on the ground mentioned in the Show Cause Notice.

In view of the above, the committee decided as under:

The Committee is of the opinion that application bearing Code No. ERCAPP201646270 of the institution regarding permission of applied additional intake in B.Ed. Programme is refused under section 15(3)(b) of NCTE Act 1993".
